Important visa information:

All passengers – only except of US or Canadian citizens – need a B1/B2 visitor visa for the USA because the freight shipping company does not participate in the US visa waiver program (they are not approved carriers for visa waiver regulations). Passengers who cannot present a valid US-visa at the beginning of their voyage will be excluded from the voyage.

In the American port you will be picked up by a security officer and driven to the local Immigration Office. Here your entry will officially be registered by the authorities and your luggage will be x-rayed by the customs. When a passenger returns to his home country, his departure also needs to be registered by the official authorities (please see reverse page with USA embarkation information).

All taxi costs for the transport to the immigration office or to the vessel have to be paid by the passenger right away. The escort service costs USD 15 (at present) and is provided by the local cargo agency.

If you do not follow the above procedure, <u>you have to reckon with a penalty of 5000 USD per</u> person.

The shipping line asks all passengers who depart from Chester or Wilmington to contact the respective agency not earlier than one week before departure. Please ask the agency for the vessel's current schedule.
