

DECLARATION

in connection with the voyage on board the cargo vessel of shipping company Grimaldi Lines Freighter Travel

Each undersigning passenger declares that he/she has been informed that this vessel on which the voyage will take place has only limited passenger accommodation.

The passengers are also informed

- >that the vessel will accept and carry any cargo subject to laws and regulations, including animals and other merchandise,
- >that the sailing schedules and the ports of call are subject to cargo requirements, and that consequently sailing and arrival dates cannot be guaranteed,
- >that alterations of any kind might occur at very short notice and vessels may be substituted with ones of limited or no accommodation capacity, in which case my reservation might be cancelled (the shipping company will eminently strive to render a substitute offer at once),
- >that a temporary landing cannot be guaranteed in case the vessel is not alongside the pier but will anchor outside the port,
- >that Passengers are never allowed to leave the ship before they have been cleared by local custom and immigration authorities in every port called.

All necessary travel documents like the international passport and vaccination passport have to be given to the captain or 1st officer for the duration of the stay aboard.

Passengers are informed that the vessel does not carry a physician on board and that they must notify the shipping company or travel agent of any corporal disabilities at the time of reservation. A medical certificate has to be presented upon specific requirement to the travel agency, declaring that there is no objection against travelling on a cargo vessel.

In case of illness or injury happening in the course of the voyage, passengers may apply for attendance by an officer of the vessel and for medicaments as far as available on board. A health and accident insurance is obligatory.

Any incurred expenses for services for the agencies in the ports of call must be payed by the passengers directly. Should it not be possible, the Hamburg Süd Reiseagentur GmbH will charge the costs after the return.

If Passengers book a one way voyage, they will assure that they have a return ticket (ship or flight).

Due to stricter international security codes there may be intensive checks of luggage and/or passengers including personal search by security authorities or appointees, i.e. the ship's security officer. Passengers are aware that such examinations may interfere with their privacy for which the carrier cannot be held responsible. The entrainment of arms/weapons and any kind of drugs is strictly forbidden. Passengers must also acknowledge that authorities may search any area of the vessel and any item/person on the vessel at any time without prior notice.

The booked voyage is for private purpose only without any journalistic background. A written acknowledgement of the above mentioned shipping line has to be given for publishing any kind of material either in audio/written or pictorial form.

Passengers are responsible for observing all formalities. All visa regulations mentioned in our travel documents are without guarantee of correctness. Passengers must contact the relevant embassies to get definite informations regarding necessary visa.
