INFORMATION

The Aranui, a one of a kind custom built vessel, is a hybrid passenger cruise ship and freighter. In addition to its trade line to the Marquesas Islands, about 1500 km from Tahiti, it also sails to other remote islands in the South Pacific such as the Austral Islands as well as Pitcairn Islands, and the Gambier Islands, which are even further away.

The islands have few paved concrete roads leading to the village area. Our shore excursions take us to vista points that offer some of the most magnificent sights of the islands, hiking on uneven terrain – unpaved dirt and rocky roads. Coupled with high heat and humidity, especially during their summer months can be quite challenging, but well worth the trek. While the ship is handicap accessible, the islands themselves are not. Thus, this trip may not be the right fit for everyone, especially anyone with mobility issues.

The Aranui has a well-equipped infirmary stocked with medicine and medical equipment as well as a doctor and nurse on-board most capable of treating minor injuries or ailments. Once out at sea, the nearest medical facility can be many miles away, which can delay the required treatment needed. If a serious medical emergency should arise while the ship is out at sea, our medical staff can stabilize the injuries/conditions and either evacuate the guest to the nearest medical facility by air or return the ship back to Tahiti.

The company has implemented protocols to handle viral spread, such as COVID-19.

Given the favorable evolution of the Covid-19 epidemic, resulting both from vaccination campaigns and acquired immunity by the viral circulation of the different variants, many countries and cruise lines have recently eased their health protocols.

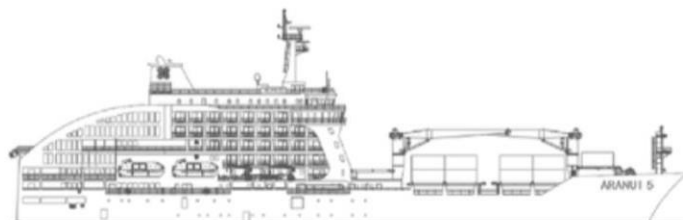
Following this global trend, starting on February 10th, 2023, Aranui Cruises will no longer require proof of **Covid vaccination** to board ARANUI 5.

However, the company will maintain as part of its health protocol the isolation measures in the event of a Covid-19 infection detected during the cruise.

AFFIDAVIT

I, the undersigned, declare that I have been informed of the conditions for the operation of the proposed cruises offered by C.P.T.M./Aranui Cruises and accept any potential consequences associated with the remote access to hospital-level medical facilities during the trip.

I authorize the company doctor to enter into confidential contact with my attending physician to clarify certain points after reading my medical questionnaire.

I understand that the risk of viral contamination exists on board as well as on land despite all the preventive protocols in place and agree to follow all instructions given, on board and during stopovers. I understand C.P.T.M./Aranui Cruises reserves the right to disembark any passenger who fails to follow protocols.

I accept the possibility to remain on board, or to disembark the ship as well as to all modifications to the cruise as deemed necessary by C.P.T.M./Aranui Cruises in the event of personal contamination while on board.

I understand that I will be responsible for all costs associated with accommodations and meals as well as medical and evacuation costs as a result of my disembarkation.

I am advised that I will not be reimbursed in the event of self- quarantine.

I am informed that I will be confined to my cabin for a minimum of 5 days. An antigen test will be carried out after 5 days. If negative, the quarantine will be lifted. In case of positivity, quarantine will be extended by 2 days. A negative antigen test is required to be released from quarantine.

If I share my cabin with another person, he or she, even if negative, will be tested every morning to be able to circulate throughout the ship, wearing a FFP2 mask and strictly respecting social distancing.

I certify that I have purchased insurance to cover medical and evacuation costs and have forwarded the insurance company information to C.P.T.M./Aranui Cruises.

I certify that I have read and understood the information given and I have truthfully completed the medical questionnaire.
