## REQUIRED FORMALITIES

- ° Valid passport (6 months after arrival date)
- ° VISA China
- ° Yellow fever vaccination certificate mandatory
- ° Return flight ticket to original country mandatory to disembark in Port Kelang

**Passengers embarking in Shanghai :** Only China visa « M » ou « C » is accepted and mandatory

**Passengers disembarking in Shanghai :** China visa « M » is mandatory.

Yanshan terminal is situated at about 100 kilometers from Shanghai City. The cost from terminal to city is about 90 \$.

**Passengers disembarking in Busan :** Immigration fees of about 100/150 USD per pax will be requested at the arrival in South Korea.

**Passengers embarking or disembarking in Malaysia:** authorities will demand you to pay handling fees 50 \$ (USD) while arriving in the port.

**Passengers embarking and debarking in Singapore:** authorities will demand you to pay handling fees 50 \$ (USD) while arriving in the port.

Additional taxes may be applied according to immigration / port agents during embarkation or disembarkation at stopovers; they are to be paid on-site in cash only.
